### Qatar Work Visa Documents Required

Before starting work in Qatar, foreign employees will require a work permit as well as a residency permit. When applying for a work permit, you'll need the following documents:

A copy of the employee's passport

Two passport photographs

Any relevant educational certificates

The immigration card of the employer

The employment visas

Biometrics, including fingerprints

The employment contracts

A duly completed application form from the Ministry of Labor

A medical certificate proving that the employee is in good health

The following papers must be submitted in order to get a residency permit:

A copy of the company's Commercial Registration

A copy of the business's immigration card

The employee's medical certificate

A valid passport

Two passport photographs of the employee

The employment visas

### What Are the Steps to Get a Work Visa in Qatar?

A passport and a good conduct certificate from the nation that issued the passport are required. You must also provide a certificate demonstrating academic qualifications, which must be translated into Arabic.

When you send documents to the Qatari Ministry of Foreign Affairs, they must be verified by your country's embassy.

To complete your application, you must schedule a medical checkup to get tested for hepatitis and HIV. The test results will be transmitted to the Criminal Evidence and Information Department through the internet. Finally, your fingerprints will be taken.

After getting their work permits, employees can go to Qatar. You must apply for the employee's residence permit within seven days of arrival. The necessary documents are stated in the preceding section and must be submitted to the Ministry of Labor.

The person can start working in Qatar after the residency permit is obtained. The person is only allowed to work with these permits. Permits can be renewed on a case-by-case basis.

### Costs of work permits in Qatar

In Qatar, obtaining a Work Residence Permit may be extremely costly. The good news is that your company will generally cover the cost for you.

The cost of an employment entrance visa to enter the nation is QAR 200. A cost of QAR 500 is required to convert this to a Work Residence Permit. As previously indicated, the cost of other visas is often approximately QAR 200.

### Changing or renewing work permits in Qatar

Through the government's Residence Services site, your employer can renew your work permit for one to three years. Employers who have been approved have Qatari Smart ID cards, which allow them to apply for jobs online.

Three months before the existing permit expires, you can apply to renew it. The following are the fees:

Employees sponsored by corporations are eligible for a QAR 1,000 stipend.

Sponsorships for your spouse and children are valued at \$500 each.

Employees on personal sponsorships receive \$300.
