- 7. Market value and date of noncash compensation
- 8. Information about payments made under sick-pay plans
- 9. Withholding exemption certificates
- 10. Agreements regarding the voluntary withholding of extra cash
- 11. Dates and payments to employees for non-business services
- 12. Statements of tips received by employees
- 13. Request for different computation of withholding taxes

#### Social Security (FICA) Tax Records:

- 1. Amount of each payment subject to FICA tax
- 2. Amount and date of FICA tax collected from each payment
- 3. Explanation for any difference
